Eligibility	 Entry to the Promotion is open to residents in Australia who: (a) are 18+ years of age; or (b) have parent/guardian approval to enter and the parent/guardianhas read and consented to these terms and conditions. Employees (and their immediate families) of the Promoter and its contractors and agencies associated with the Promotion are ineligible to enter.

Number of entries Selection of winner(s)	(c) Use the hashtag #PlayFootballAUS in association with the Compliant Video. Compliant Video means any video captured in 2022 featuring a goal in an Australian grassroots football match (i.e. not NPL, A-League Mens, A-League Womens, or Y-League). One (1) entry per participant each Week. For the purposes of this Promotion, Week means each consequentiveperiod of 7 days commencing at the start of the Promotional Period. This is a game of skill. There is no element of chance involved. For each Week, (subject to at least four (4) entries being received for that Week) the top three (3) eligible entries will be selected by a panelof judges at Football Australia based on the following criteria: (a) originality; (b) football creativity; (c) difficulty; and (d) presentation of one or more of the following values: 1. enjoyment; 2. teamwork; and/or 3. community spirit, (Top Weekly Entries). Each Week, the Top Weekly Entries will be shared via Football Australia channels from 5.00pm AEST Wednesday until 5.00pm AESTSaturday (Voting Period). The entry with the most votes (using an allocated voting method) at the conclusion of each Voting Period will be named the winner. One (1) winner will be selected each Week and be awarded one (1) prize. The Promoter's decision in this matter is final and no correspondencewill be entered into.
Prize(s)	Each winner will receive one (1) x rebel Sport voucher valued at \$100.

TERMS OF ENTRY

ENTRY

- Entry is open to participants that meet the eligibility criteria as described in the Schedule. To enter, participants must follow the method of entry during the Promotional Period as set out in the Schedule.
- Entries are deemed to be received at the time the Promoter receives the entry and not at the time of thesubmission by the entrant.
- The Promoter reserves the right to verify the validity of entrants and entries (including a participant's identity, age and place of residence to enter this Promotion). Entrants must fully cooperate with the Promoter in relation to any such verifications.
- Entries that are, or include, obscene, offensive, defamatory, inappropriate, unsuitable or infringing content as determined by the Promoter at its sole and absolute discretion will be deemed invalid and are noteligible to win.
