- 1. I pledge to respect and comply with any mandatory provisions of applicable national and international laws, including in particular those relating to job placement when carrying out my activities as an agent. In addition, I agree to be bound by the statutes and regulations of Football Australia Limited (FA), associations and confederations, as well as by the statutes and regulations of FIFA in the context of carrying out my activities as an agent.
- I declare that I have made no false or misleading or incomplete statements in my licence application to FIFA.
- 3. I declare that I am currently not holding a position of Official (as defined in point 13 of the Definitions section of the FIFA Statutes) or employee of FIFA, a confederation, a member association, a league, a club, a body that represents the interests of clubs or leagues or any organisation connected directly or indirectly with such organisations and entities (except where I have been appointed or elected to a body of FIFA, a confederation or a member association, representing the interests of Football Agents*), nor will I hold such a position in the foreseeable future.
- 4. I declare that I have an impeccable reputation and in particular confirm that I have never been convicted of a criminal charge, including any related settlements, regarding matters related to: organised crime, drug trafficking, corruption, bribery, money laundering, tax evasion, fraud, match manipulation, misappropriation of funds, conversion, breach of fiduciary duty, forgery, legal malpractice, sexual abuse, violent crimes, harassment, exploitation or child or vulnerable young adult trafficking.
- 5. I declare that I have never been the subject of a suspension of two years or more, disqualification or striking off by any regulatory authority or sports governing body for failure to comply with rules relating to ethics and professional conduct.
- 6. I declare that I do not hold, either personally or through an Agency*, any Interest in a club, academy, league or Single-Entity League*.





- 7. I declare that I have no contractual relationship with FA, leagues, associations, confederations or FIFA that could lead to a potential conflict of interest. In the case of uncertainty, any relevant contract shall be disclosed. I also acknowledge that I am precluded from implying, directly or indirectly, that such a contractual relationship with FA, leagues, associations, confederations or FIFA exists in connection with my activities as an agent.
- 8. I declare that in the twenty-four months before the submission of my licence application to FIFA, I have never been found performing Football Agent Services* without the required licence.
- 9. I declare that in the five years before the submission of my licence application to FIFA (and subsequently thereafter, including after being granted a licence) I have never declared or been declared personally bankrupt or been a majority shareholder, director or key office holder of a business that has declared bankruptcy, entered administration and/or undergone liquidation.
- 10. I declare that in the 12 months before the submission of my licence application to FIFA (and subsequently thereafter, including after being granted a licence) I have not held any Interest* in any entity, company or organisation that brokers, arranges or conducts sports betting activities whereby a wager is placed on the outcome of a sporting event in order to win money.
- 11. I declare, pursuant to item 1.3(b)(iii) of Schedule 3 of the FA National Registration, Status and Transfer Regulations (NRSTRs), to hold and lodge with FA, in the manner and form prescribed by FA from time to time, a validated working with children check, or the jurisdictional equivalent.
- 12. I am fully aware and agree that this declaration may be made available to the members of the competent bodies of FA, associations and confederations, and FIFA.
- 13. I consent to the collection, use and disclosure of my personal information as described in this declaration and for the purposes set out in FA's privacy policy (available at www.footballaustralia.com.au), including administering FA's Football Agent Regulations.
