**NOTE: Providing false or misleading information could result in the immediate cancellation of registration.**

Once duly completed, this form is to be sent to the relevant Member Federation (i.e., the body that conducts and manages the competitions that the Club participates, or intends to participate, in). Once the Member Federation has approved the Club's application and has indicated as such in the official section, this Prescribed Form will be forwarded to Football Australia.

All information contained on this Prescribed Form is to be entered into Play Football by Football Australia.

Club Details:

Insert the name of the Club and the type of football the Club will be participating in e.g., Outdoor, Futsal or Beach.
