5. agrees that it will comply with the requirements regarding the release of Players for National Teams as provided in the NRSTRs as promulgated from time to time;
6. agrees that it will ensure all Officials registered with the Club comply with any fit and proper person test promulgated by FA from time to time;
7. must not, and must ensure that its Players and Officials do not, communicate directly with FIFA or a confederation or national member association of FIFA, unless otherwise directed or approved by FA in writing;
8. must comply with all requirements and directions of FA and Sport Integrity Australia (**SIA**) in relation to integrity matters, including education and anti-doping testing;
9. must, and must procure that each Player and Official agrees to:
 - (a) cooperate in good faith with all investigations conducted by or at the direction of FA in accordance with the FA Statutes;
 - (b) if requested by FA in accordance with the FA Statutes, produce documents related to any matter that is the subject of an investigation conducted in accordance with the FA Statutes;
10. acknowledges that providing false or misleading information may result in cancelation of registration;
11. acknowledges and agrees that it has obtained all necessary consents to provide the personal information contained in this form to FA, which information may be used by FA for the purpose of administering football and as set out in FA's Privacy Policy available at www.footballaustralia.com.au/privacy.
1. agrees not to bring any Claim against APLCO and FA for any Loss (including Consequential Loss) the Club or a Player may suffer from the Club or a Player participating in, or a Player being excluded from participating in, the Nominated Leagues.
